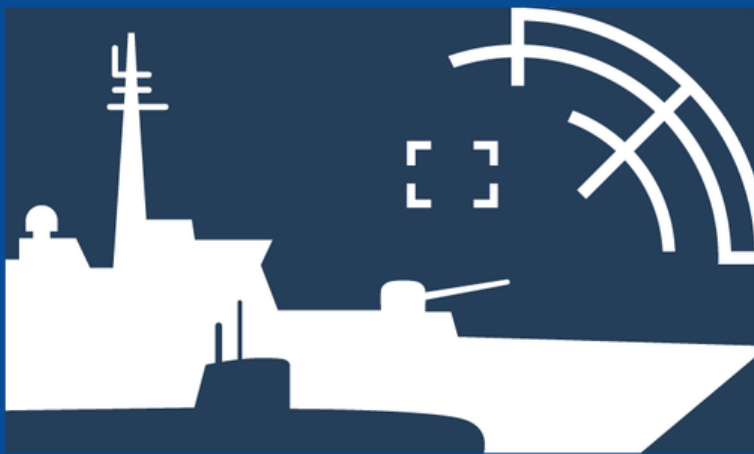

ADDITIONAL INFORMATION

NET AREA

This is an open space for the construction of special projects displays, or machinery exhibitions.

FASCIA BOARD

It is a front fascia panel located at the top of the booth. It includes the stand number and the exhibitor´s name.

MATERIALS MODULAR BOOTHS

Panels: MDF with white PVC adhesive film.

Structure: Light gray aluminum profiles.

Panel dimensions: 1 m wide and 2.50 m high. The usable dimensions are 0.95 x 2.40 m (visual area).

FAIR POWER SUPPLY

Any electrical modification to the system provided by FISA must be supported by an electrical project and carried out by a qualified electrical professional (Class A or B).

MODULAR BOOTHS

- Includes a power outlet with a maximum load of 70 watts per m²
- It may supply power to one or more devices that have the corresponding SEC certification and approval label.
- It may not supply power to installations other than those within its own stand (including outlets, lighting, or LED screens, as these require a TEI electrical declaration).
- Connecting one power strip to another is strictly prohibited.

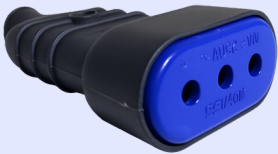
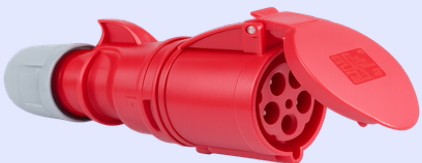
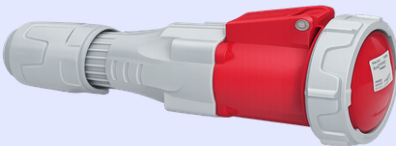
SPECIAL PROJECTS

- All documentation related to the project submitted to the SEC must be available (drawings, reports, and technical specifications).
- Each stand includes one electrical outlet with a maximum electrical load of 70 W per m² in the indoor exhibition area and 35 W per m² in the outdoor exhibition area.
- The documentation must be available for inspection by the declaring installer, distribution installers, the event's electrical coordination team, or the SEC.
- Special projects that do not have their printed documentation available at the stand will not be authorized for power supply.

PLUG AND MALE CONNECTOR REQUIREMENTS

- Use male plugs/connectors suitable for the required power capacity.
- Protection Rating (IP): plugs/connectors must comply with the appropriate IP protection rating according to the installation environment.
- Outdoor use: minimum IP65, fully protected against dust and low-pressure water jets.
- Indoor use: minimum IP44, protected against solid objects larger than 1 mm and water splashes.
- In humid areas, plugs/connectors must be installed at an elevated position to avoid contact with water.

IMPORTANTE:

- If the power assigned according to your stand area (m²), plus the additional power purchased, exceeds 3.5 kW, a 32A single-phase industrial outlet will be provided. This will still be single-phase power; however, you will be responsible for the internal power distribution, as a standard domestic power outlet will not be available.

Please review this point carefully. Each case may vary depending on the stand area (m²) and the additional power requested.



STANDARD SINGLE-PHASE CONNECTION FOR MODULAR STANDS

This is the plug provided in modular stands with single-phase electrical supply. The connection includes a circuit breaker for electrical protection, allowing exhibitors to safely connect their equipment in compliance with the fair’s electrical installation.

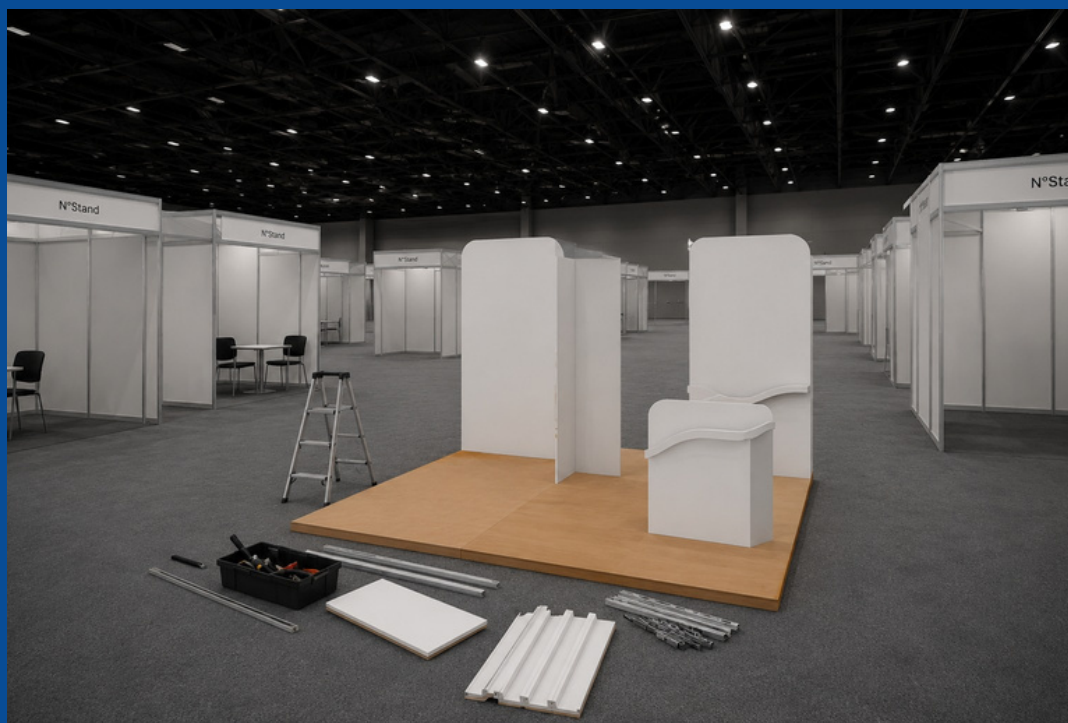
PROJECT APPROVAL

¿WHAT IS A CUSTOM STAND PROJECT?

A Custom Stand Project is any stand that involves a construction different from the standard modular stand provided by FISA.

This includes, but is not limited to:

- Stands built on raw exhibition space (without standard modular structure).
- Modifications to a rented modular stand (such as removing panels, fascia boards, structural elements, etc.).
- Stand constructions that exceed the standard height limits or include special structures, suspended elements, LED screens, hanging signs, second-story structures, or other technical features.

HOW DOES THE PROCESS WORK?

1. Complete the form provided by FISA and indicate whether your stand qualifies as a Custom Stand Project.
2. Once we receive your information, our Project Approval Team will contact you to guide you through the approval process and request the required documentation.
3. Your submitted documents will be reviewed, and you will be informed whether your project:
 - Has been approved.
 - Requires revisions or adjustments.
 - Requires additional information before approval can be granted.
4. Only approved projects will be authorized to begin construction during the move-in period.
